NEW HOME FOR THE LATHAM HOUSE AND A REPORT ON THE MARIES COUNTY HISTORICAL SOCIETY


One of Vienna's oldest houses, the Latham House, a rugged log structure that is almost 140 years old, is scheduled to be moved sometime in the near future to a permanent site on the Old Jailhouse property. This has been the dream of members of the Historical Society of Maries County since the structure was moved in the late 70's to its present temporary site on Ballpark Road.

Moving and restoring the historic landmark took several years to complete, as the process required careful dismantling, labeling of the logs, and log-by-log reconstruction. A foundation was constructed of stones taken from the site of an old building that had already been torn down in Vienna. The house was reconstructed exactly as it was originally. A shake shingle roof and a front porch were added, the designs of which were suggested by the memories of some community elders. The same meticulous work will be required in the Latham House's proposed move to a site just east of the restored Felker House.

A respectable amount of funds already has been raised to fund the moving of the Latham House to a permanent site. However, additional funding is needed. Contributions may be sent to the Historical Society of Maries County, Box 289, Vienna, Missouri 65582.

Any county wishing to start an historical organization can look to the Historical Society of Maries County as an excellent model. The society actively promotes the preservation of historical structures and artifacts, does historical and genealogical research, and elevates public awareness of that county's rich heritage.

One of the services of the Historical Society of Maries County is the maintaining of a free historical research room that's open to the public Wednesday mornings from nine to noon at the county courthouse in Vienna. This helpful to both historical researcher and genealogist alike.

The society's newsletter is one of the finest in the state. It regularly features old newspaper articles and obituaries, court and other county records, census records and old store ledgers, long-ago school and church registers, society projects, and memos from members. 

Society members are very active in preserving Maries County historical structures. Of primary interest are three pre-Civil war buildings still standing in Vienna. These are the OLD JAIL MUSEUM, the FELKER HOUSE, and the LATHAM HOUSE.

At the present time, the OLD JAIL MUSEUM and the FELKER HOUSE are located next to each other a block east of the Highways 63 and 42 intersection. This is the original location of the OLD JAIL MUSEUM. Several years ago, the FELKER HOUSE was removed from its original site and reconstructed just south of the old jail.

OLD JAIL MUSEUM: This structure of limestone blocks, constructed in 1856, served for 85 years as the Maries County jail. Visitors can walk an old staircase to the upstair cells and get a feel of what it was like to have been a prisoner there. There is still graffiti on the wall that was written by prisoners of many years ago.

Downstairs, in what was the sheriff's quarters, the Historical Society of Maries County has meticulously placed and labeled many fascinating historical artifacts. Every item has a little story attached. Documentation and credit have been given


whenever possible.

The museum is open to the public during the summer months every Sunday afternoon from 2 to 4 o' clock. A visit there is well worth the time and effort.

FELKER HOUSE: This log structure was built in 1854-55 by John Felker and his wife Amanda following their return from a cattle drive to California. For 104 years it stood two blocks east of its present location near the Old Jail Museum.

LATHAM HOUSE: Built in 1855 by Dr. Valsain Gaylove Latham, this log house present resides at the entrance to the community park in Vienna. The Historical Society of Maries County plans to move it soon to a site east of the Felker House on the Old Jail Museum property. The society is raising funds for this purpose and welcomes all contributions.

located on the Old Jail Museum property. which houses various artifacts and displays, including the old Vichy postoffice counter and boxes.

Visitation Catholic Church, located on Highway 42 just east of the Highways 63 and 42 junction, was built early this century by Father John Fugel and members of his parish. The concrete blocks were all made in Vienna by a machine the parish purchased. The first block was placed in position on November 22nd, 1905. The block office across the street, now the home of the Lemberger Company, also was constructed in this manner. It was built to house Father Fugel's "The Home Adviser", a local newspaper published from about 1903 until his death in 1936.

When the present Visitation Catholic Church was constructed, the metal cross on top of the old structure was replaced. Father Fugel asked that the cross, which now is displayed on the lawn in front of the Old Jail Museum, be used as the only marker to his grave when he died. The parish complied with his wishes, but a decision was

made some years later to replace the crucifix with a regular tombstone. The old cross was discarded and all but forgotten until it was rescued some years later.

Visitors to Vienna will find it a rewarding experience to visit the Maries County courthouse, where there is a display of 40 pieces of locally produced artwork that depicts people and places in Maries

Some other interesting sites include the rustic "Swinging Bridge", located two miles west of highway 63 down Vienna's Ballpark Road; Clifty Hollow Natural Bridge, located on W Highway near the Clifty Creek Conservation site; Paydown Mill at Paydown on Highway 42; the Spring Creek Gap Glades Natural Area; and John Viessman's rural school houses mural in the Vienna school cafeteria.
